a. Third quarter SCMAD budget review.

Manager Snyder presented the third quarter budget review ending 3/31/22. He highlighted the district has expended 62% of budget for services and supplies and 56% of budget for salaries and benefits.

b. Consideration/Action to consider lump sum payment to the district's California Employees Retirement Benefit Trustee Account. (CERBT).

Manager Snyder stated that the district had budgeted \$300,000 for the CERBT account and would like the board's approval for the expenditure.

Manager Snyder presented the board with 3 bids for resealing the approximate 67,000 square feet of asphalt at the district's facility. The three bids were: G & S Paving for \$44,327.35, Tri-Valley Striping for \$26,640.00, and Stalls & Stripes Inc. for \$16,680.00.

Unanimously approved on motion to award bid to Stalls & Stripes, Inc. for \$16,680.00 by Trustee R. Meador seconded by Trustee Anderson.
