1. Call to order:

Vice-President Schock called the meeting to order at 7:30 p.m. at the Solano County Mosquito Abatement District Building, 2950 Industrial Court, Fairfield, CA. 94533

10. New Business:

a. Presentation by Vector Control Consultant Karl Malamud-Roam on potential source reduction project on Mare Island.

Karl Malamud-Roam did a PowerPoint presentation on a proposed source reduction project that the district would like to complete. The district hired Karl to do a feasibility study on whether the source reduction project could be completed on Mare Island, Karl highlighted both potential constraints as well as benefits to a tidal marsh enhancement project. Potential constraints include flood risks, potential contamination of site, property ownership, concern/constraint of ecological values within the marsh. Trustee Schock asked if Karl had an estimate for the cost of project, Karl stated that he would put together an estimate for the board, also stating that there may be grants/funds available through Measure AA monies. Trustee Anderson asked about liability to the district related to contaminates that may be within the proposed project site. Karl stated that he has completed similar projects in the past and that the district counsel Richard Shanahan has written contracts and could complete a contract for the district that would protect the district from liabilities. Trustee Schock asked if a liability bond could be purchased to protected the district from liability issues, Karl responded that could be a possibility.

b. Consideration/Action on proposal from Maze and Associates for auditing service for FY 2020-2021 and 2021-2022.

Unanimously approved on motion by Trustee R. Meador seconded by Trustee R. Stevenson.

c. Consideration/Action on pay down of SCMAD unfunded liability with CalPERS.

Manager Snyder presented to the board a lump sum payment letter from CalPERS showing that a projected total unfunded liability as of June 30, 2021 is \$663,421.00 and if the district were to pay lump sum payment of \$500,000.00 the post payment total unfunded liability would be \$162,865.00. He also stated that this would bring the district to 98% funded of the district's CalPERS retirement account. Trustee Schock stated that the district currently in paying 7% interest on unfunded liabilities and that paying this amount would save the district accumulated interest costs.

Unanimously approved on motion by Trustee R. Meador seconded by Trustee J. Anderson.

d. Consideration/Action on payment of \$250,000.00 to SCMAD CERBT fund.

Manager Snyder presented to the board a CERBT account update showing that the district assets in the account as of June 10, 2021 were \$1,377,788.00 and total liability as of June 30, 2019 was \$1,781,258.00. If the district were to contribute a lump sump payment of \$250,000.00 this would bring the funded level of the account to 89% funded.

Unanimously approved on motion by Trustee J. Anderson seconded by Trustee R. Meador.
